- 2. School Projections and Staffing-we are projected for 279 students next year; we have 26 Kindergarten students registered so far; we have been staffed for 13 divisions (down one from this year) this can change based on our actual enrollment in September

3. Covid 19-Continuity of Learning

- Thank you parents and families for your patience as we navigate this new way of learning.
 We know that balancing work and the social and emotional needs arising from what is happening is challenging and hard for families
- Teachers and support staff worked hard to continue learning opportunities at home variety of tools used TEAMS, FreshGrade, email, Remind etc to share learning activities
 and connect with students and families
- Video Conferencing is an optional tool some teachers are using it and others aren't depends on needs of class and teaching staff as well.
- Technology- we have loaned iPads and Laptops to families that need it to access learning at home
- When, and if, the government gives a return date to schools it will be a well planned coordinated effort with the whole district - priorities will continue to be Health and Safety for all with many routine procedures in place. More to come...

New Business/ Updates	6. Cancelled events update from Amanda – everything is cancelled We're not planning anything for next year yet as we don't know what school will look like
	7. Update from Sharon - there are currently \$1701.25 worth of credits on Munch A Lunch from cancelled lunches. Credits will be applied to accounts next school year once school is open. Two families have asked for refund cheques as their students are graduating. One family has asked to donate their credit to the PAC for us to buy lunch for a student that would not normally be able to buy fun lunch
	Popcorn money from cancelled Kernels treat day - hoping to hold the cash until next year or when school reopens for item pick up
	8. Fun night update from Kam – cancelled, our carnival games deposit is being held as they are not offering refunds right now. They will offer a refund once they've got some cash flow again.
	9. Update from Amanda – AGM is scheduled for June 2, we want to postpone this until after school is back up and fully running.
	10. Update from Amanda – we need to update the constitution to allow for AGM deferral in extraordinary circumstances. Add a section about extended school closures and dealing with the AGM. We have to write up a clause saying that the AGM would take place within a certain amount of time after school fully reopening. Amanda will work on this and next meeting we will vote in the changes. This will allow deferral of AGM.
